

# An Open Letter from Illinois Clergy and Faith Leaders on Marriage

We represent people of faith from a variety of communities across our state, and we strongly support the Illinois Religious Freedom and Marriage Fairness Act. We dedicate our lives to fostering faith and compassion, and we work daily to promote justice and fairness for all. Standing on these beliefs, we think that it is morally just to grant equal opportunities and responsibilities to loving, committed same-sex couples. There can be no justification for the law treating people differently on the basis of sexual orientation or gender identity.

We accept our gay and lesbian brothers and sisters and recognize that their families need equal recognition and protections. We believe all Illinois couples should have the same civil protections and urge our public officials to support measures to achieve equality.

There are differences among our many religious traditions. Some recognize and bless same-sex unions, and some do not. The important thing is that the Religious Freedom and Marriage Fairness Act protects religious freedom and guarantees that all faiths will decide which marriages should be consecrated and solemnized within their tradition.

The sacred writings and traditions that we follow carry the messages of love, justice and inclusion. The very basis of marriage is to protect the family, strengthen our communities and advocate compassion. No couple should be excluded from that.

We want to promote the common good – that which is best for individuals, couples, families, children, and society. As people of faith and as citizens of Illinois, we ask you to stand for freedom for all of our citizens and support the freedom to marry. It's not only a matter of equality – it's a matter of conscience and justice.

Dear Sisters and Brothers in Christ:

I am writing today to express my support for the bill currently before the Illinois legislature that would allow same-sex couples to marry legally. As I am sure you are aware, my support for this legislation imposes no duties on you. I cherish the fact that the Episcopal Church trusts its members to arrive at their own conclusions about moral and political issues. I would like to say a few words, however, about how I came to my opinion, in part because I believe I owe it to you as your bishop, and in part because I believe that the Christian argument for legal marriage equality is not well understood.

The state of Illinois and the Christian church face different questions in determining whether it is good and wise to allow same-sex couples to marry. If one believes in equality before the law, it is extremely difficult to justify denying the benefits of civil marriage to

extremely difficult to justify denying the benefits of civil marriage to same-sex couples. Opponents of the current legislation would have to present compelling evidence that marriage equality will harm our state so deeply that we must continue to deny same-sex couples the rights that opposite-sex couples freely claim for ourselves. I do not believe that the experience of states and countries in which same-sex couples are already free to marry legally supports this case. Rather, extending the benefits of civil marriage to same-sex couples has made it easier for them to order their lives together, to care for one another and to raise children in a stable home. Creating stronger, happier households contributes to the common good, and that is enough reason to support any legislation.

The debate over marriage equality, however, is seldom decided entirely on its merits as sensible public policy. Because both church and state claim authority over the institution of marriage, the debate always takes a theological turn. I do not believe the state owes the church any deference in defining civil marriage. But my own convictions about the nature of marriage and the sort of laws that should govern it are inescapably shaped by my Christian faith. I also hope that the current civil and religious debates about marriage equality and the blessing offered by the church to same-sex couples will enrich the understanding of Christians and other people of faith about the nature of all committed life-long relationships.

I believe that marriage is a sacred vocation. The union of two persons in heart, body and mind is a school of holiness, a way of ordering our lives so that we might learn to be more faithful servants of Christ. I also believe that the faithful, loving, and lifelong union of two persons--of the same sex or of opposite sexes--is capable of signifying the never failing love of God in Christ for the church and the world. Such unions can be sources and signs of grace, both for the couple and for the wider community.

As a Christian, I believe that our society needs all of the sources and signs of grace that we can get. As a citizen of the United States, I believe in equal protection under the law. I believe that both ends will be served when marriage equality is the law of the land in Illinois, and I am grateful to be bishop in a church that offers all couples a community of faith, love, support and accountability.

Bishop's statement on Illinois Marriage Equality Bill 01/10/2013

Today the new General Assembly of the State of Illinois is expected to discuss and soon vote on the Religious Freedom and Marriage Fairness Act. It is expected that it will pass into law. I want to express my views on it and my support of it as law.

I believe in the institution of marriage as the source of emotional and legal stability and security for families and communities.

In May I will have been married for 37 years. I have many friends who are not presently married and have never married, but I believe most of them have wanted to find a lifelong relationship to which they are committed for spiritual, physical and emotional comfort and support.

And I have friends, acquaintances and former parishioners who have been in lifelong relationships with someone but have not been able to have their relationships recognized by the state or the church because they are in a same-sex relationship. In spite of all the same pressures and stresses that heterosexual couples face, they have managed to stay faithful and true to each other, providing stability and strength not only for their families but for their communities and churches.

Marriage also provides stability and security for me in a way that I usually take for granted especially as both my husband and I grow older. We just assume that we can be with each other in the emergency room or that if, God forbid, something happens to the other that we will be provided for through our combined resources. After all, we've built those resources together over the last almost 37 years.

But same-sex couples can't assume the same benefits, not even the benefit of being with each other should there be an emergency or in critical last moments to hold the other's hand...no one should have to be getting permission to be by a loved one's side at a time like that but that is the reality for same-sex couples.

I believe in marriage because it also is the institution that best provides for the well-being of children. I believe that children need to have parents who have the emotional and legal benefits of marriage as well as parents who are active in their lives.

In addition to the benefits of marriage that I have described above, I also believe that the State of Illinois needs to be on the forefront (if #10 of 50 is the forefront) of providing for marriage equality in order to promote economic growth. People look for places to work and start businesses that will attract as many good workers, entrepreneurs and business people as possible and a marriage equality state can provide that added edge to the competitive economic market.

While the United Methodist Church holds that the practice of homosexuality is incompatible with Christian teaching, it also holds the teaching and a long tradition (albeit a struggle every inch of the way) of civil rights. Marriage equality is a civil rights issue; it provides for all what is afforded to some.

The marriage equality act in Illinois does not bind anyone who is licensed by the state to perform marriages to perform a marriage for a same-sex couple (as no one can bind us to perform a marriage for a heterosexual couple). In fact, even though I support this legislation, I can't perform a same-sex marriage as a United Methodist clergy person and as the bishop I can't give permission to any other clergy to do the same. But just because I can't provide the service of marriage to same-sex couples doesn't mean that I should prevent people from being able to commit their lives to each other in the State of Illinois.

Therefore, I believe it is to the benefit of our families, communities and the state of Illinois for the Marriage Equality Bill to become law in our state. Not all United Methodists will agree with my belief on marriage and they are entitled to their own belief. Because I believe in marriage, it's my belief it will be a benefit for this law to pass.

# A RESOLUTION SUPPORTING THE ILLINOIS RELIGIOUS FREEDOM AND MARRIAGE FAIRNESS ACT

Whereas, the bill called the Religious Freedom and Marriage Fairness Act bill was introduced in the Illinois state General Assembly in February of this year and would provide that "all state laws applicable to marriage apply equally to marriages of same-sex and different-sex couples and their children" and grant them "the same benefits, protections, and responsibilities under law"; and

Whereas, the Religious Freedom and Marriage Fairness Act would also ensure that every religious tradition can decide for itself whether or not to officiate at marriage ceremonies; the Act would not require religious traditions to recognize or solemnize marriages between samegender partners; and

Whereas, those states, including Illinois, that have created civil union as a means of both providing legal protections while withholding the freedom to marry have recognized that civil union falls far short of marriage with all its tangible and intangible significance in our lives; and

Whereas, the ELCA's Social Statement "Human Sexuality: Gift and Trust" acknowledges the existence within the ELCA of a wide range of conscience-bound beliefs regarding committed same-gender relationships and calls upon "all people to live out their faith in the local and global community of the baptized with profound respect for the conscience-bound belief of the neighbor;" (p.21) yet further states that "While Lutherans hold various convictions regarding lifelong, monogamous, same-gender relationships, this church is united on many critical issues" (p. 19). This church:

- 1. "supports legislation and policies to protect civil rights and to prohibit discrimination in housing, employment, and public services." (p. 19)
- 2. "has called upon congregations and members of this church to welcome, care for, and support same-gender couples and their families and to advocate for their legal protection." (p. 19)
- 3. "will advocate for public policies that support and protect families." (p. 24)
- 4. recognizes that some faithful Lutherans "conclude that marriage is also the appropriate term to use in describing similar benefits, protection, and support for same-gender couples entering into lifelong, monogamous relationships" and that "they believe that such accountable relationships provide the necessary foundation that supports trust and familial and community thriving;" (p. 18);

THEREFORE BE IT RESOLVED, that the Metropolitan Chicago Synod, meeting in Assembly, calls upon congregations and members of this synod to welcome, care for, and support samegender couples and their families and to advocate for their legal protection; and

BE IT FURTHER RESOLVED, that the Metropolitan Chicago Synod, meeting in Assembly, urges the Illinois Legislature and Governor to extend the protections and dignity of marriage to all persons and to protect the freedom of religion for all faith communities and religious organizations; and

BE IT FURTHER RESOLVED, that the Metropolitan Chicago Synod, meeting in Assembly, urges the synod bishop (or designee) to make the synod's position on this matter known to the state Legislature, the Governor, to the congregations of this synod, and to the public at large.

## Marriage Equality and the Evangelical Lutheran Church in America Bishop Wayne N. Miller, Metropolitan Chicago Synod

In 2009, in a voting member assembly of our denomination, the Evangelical Lutheran Church in America (ELCA) adopted a far-reaching ethical statement on human sexuality entitled *Human Sexuality:* Gift and Trust.

This statement, along with the ministry policy statements that were drawn from it, represents a richly complex study of many current and historical aspects of the relationship between Christian faith and sexual ethics. Because of the careful and sometimes complicated historical and theological nuance of the study, it is both daunting and dangerous for one bishop to try to reduce this church's teaching on sexuality to a few sentences.

Nonetheless, a number of key religious leaders have recently been drawn into the debate in Illinois as to whether or not it is appropriate and advisable for the state to apply the category of "marriage" in an equal way to all monogamous adult couples, regardless of the biological gender of the partners. Because other religious leaders have spoken openly, there is also a danger that silence from ELCA leaders could be interpreted as indifference or cowardice. So, as one bishop of this church, I would like to emphasize a few key points that I hope will shed light on our present teaching.

- 1. We do not believe that divergent attitudes toward homosexuality can be used to separate faithful Christians from unfaithful Christians or responsible Christians from irresponsible Christians. We do not believe that so-called "natural law" is sufficient grounding for uniform teaching on the matter. We do not agree that same-gender marriage would necessarily be destructive to the moral fiber of our society. Also, we do recognize that the scriptural witness on the subject is sufficiently inconsistent and subject to interpretation to allow faithful and responsible members of our congregations to disagree with one another on this subject and still live together as one faith community.
- 2. Some of our pastors and congregations believe strongly that "marriage" is a word that should be restricted exclusively to apply to a life-long public covenant between one man and one woman. This is a faithful position in that it upholds an established teaching of Christianity, and it emphasizes the fact that the ELCA social statement has not changed this church's definition of the word, "marriage."
- 3. Some of our pastors and congregations, however, believe equally strongly that our identity in Christ transcends the usual categories of race, social position, and gender, and that "marriage" is a word that should apply in a completely equivalent way to any life-long public covenant between one adult and another adult, regardless of race, social position, or gender. This is also a faithful position in that it upholds the primary importance of faithfulness to promises, and it emphasizes the role of the church as an

advocate for human rights and equal protection under the law for all people, even if we do not agree with their beliefs on matters of faith and morals.

This divergence of opinion means that there is no single position on the pending Marriage Equality Act in Illinois that can be said, with integrity, to be the position of the Evangelical Lutheran Church in America.

When I became a bishop of this church I took a public oath to be pastor, teacher, and counselor to the whole ELCA, not merely to that portion of the church that agrees with my personal opinions. That is the public promise that I am committed to honor to the very best of my ability, and, because of that promise, I can only commend the members of our congregations to enter into the public debate prayerfully, with thoughtfulness, respect, compassion, and ultimate trust in the guidance of the Holy Spirit as we speak and act. This, in and of itself, will serve as a worthy testimony to what it means to be a Christian in the world.
